Summary Annual Report for IBT LOCAL 145 HEALTH SERVICES & INSURANCE FUND

This is a summary of the annual report of the IBT LOCAL 145 HEALTH SERVICES & INSURANCE FUND (Employer Identification No. 06-0711441, Plan No. 501) for the period July 1, 2021 to June 30, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

IBT Local 145 Health Services has committed itself to pay the following types of claims incurred under the terms of the plans: All HEALTH, DENTAL, VISION, ACCIDENT AND SICKNESS claims.

Insurance Information

The plan has a contract with The Hartford Life and Accident to pay the following types of claims under the terms of the plan.

ALL LIFE INSURANCE AND ACCIDENT DEATH AND DISMEMBERMENT

The total premiums paid for the plan year beginning July 1, 2021 and ending June 30, 2022 were \$4,670.

Basic financial statement

The value of plan assets, after subtracting liabilities of the plan, was \$14,085,882 as of June 30, 2022 compared to \$15,644,955 as of July 1, 2021. During the plan year the plan experienced an increase in its net assets of \$1,559,073. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$4,670,645 including employer contributions of \$5,765,314, employee contributions of \$25,920, realized gains of \$162,550 from the sale of assets, and earnings from investments of \$-1,289,265. Plan expenses were \$6,229,718. These expenses included \$989,852 in administrative expenses, \$5,239,866 in benefits paid to participants and beneficiaries.
